OGGETTO: Regime della trasformazione sotto controllo doganale –
Trasformazione di filati di filamenti sintetici – Esame delle
condizioni economiche da parte del Comitato Codice Doganale –
sez. procedure speciali ai sensi dell'art.552 par.2 del Reg.to CEE
2454/93 – Parere favorevole.

Si fa presente che nel corso della 39^a riunione del Comitato Codice Doganale sezione procedure speciali, che si è tenuta a Bruxelles il 30 ottobre 2014, è stata presentata dalla delegazione slovena per essere sottoposta ad esame delle condizioni economiche, ai sensi dell'art.552 par.2 del Reg.to CEE 2454/93, un'istanza di trasformazione sotto controllo doganale (documento di lavoro allegato) di filati di filamenti sintetici (CNC 5402 2000) provenienti dalla Cina per la produzione di filati di filamenti sintetici per cucire (CNC 5401 1090).

Al riguardo, in applicazione dell'art.504, par. 4 del Reg.to CEE 2454/93, si comunica l'avviso favorevole espresso dal Comitato circa l'accogliibilità dell'istanza sopra citata, in quanto per la fattispecie in oggetto sono state ritenute soddisfatte le condizioni economiche.

Si evidenzia che, ai sensi della richiamata normativa comunitaria, le conclusioni del Comitato vengono prese in considerazione non soltanto dall'Autorità (slovena) interessata, ma anche da qualsiasi altra Autorità doganale che si occupa di autorizzazioni e richieste simili.

Pertanto, ove eventuali analoghe istanze – concernenti merci di importazione, attività di trasformazione e prodotti trasformati della stessa tipologia - siano

presentate all'Autorità doganale italiana, le condizioni economiche dovranno intendersi del pari soddisfatte, secondo le modalità, di seguito indicate, previste nel parere del Comitato Codice Doganale:

- l'autorizzazione di trasformazione sotto controllo doganale dovrà essere rilasciata per un periodo di **validità di anni 2**;
- il **quantitativo massimo da autorizzare** deve essere uguale a quello indicato nel documento comunitario allegato:
100% filato di poliestere 29/2 – 170 Tn per anno
filati di poliestere ad alta tenacità – 400 Tn per anno
- l'autorizzazione di trasformazione sotto controllo doganale potrà essere rilasciata solo per materie prime aventi le stesse caratteristiche tecniche indicate nel documento comunitario allegato e per produrre gli stessi prodotti compensatori;
- il rinnovo dell'autorizzazione è possibile solo dopo aver effettuato un nuovo esame delle condizioni economiche in sede comunitaria.

Inoltre, in deroga a quanto previsto dalla seconda parte del punto C2) della Circolare n.30/D del 28 giugno 2001, le dogane territorialmente competenti in relazione al luogo in cui saranno effettuate le operazioni di trasformazione, o la prima di tali operazioni (in caso di trasformazioni successive), saranno competenti al rilascio della relativa autorizzazione, secondo la procedura normale (per iscritto) con utilizzo del relativo modello (allegato 67), in maniera conforme alle indicazioni del Comitato (limiti quantitativi e temporali).

Inoltre per adempiere agli obblighi di cooperazione amministrativa (art.522 DAC), delle autorizzazioni rilasciate sarà data sollecita comunicazione alla scrivente, utilizzando per l'invio dei dati ivi previsti l'apposito formulario riprodotto in appendice all'allegato 70 del citato regolamento.

Si pregano gli Uffici e le Amministrazioni in indirizzo di provvedere alla necessaria informazione degli operatori economici del settore.

PROCESSING UNDER CUSTOMS CONTROL (PCC) - (EXTRACT FROM THE APPLICATION FOR AUTHORISATION)

1. Subject:

Application to grant an authorisation for PCC for raw material:

- **100% polyester spun yarn 29/2, Quantity 170 ton per year**
- **100% high tenacity filament polyester yarn, Quantity 400 ton per year.**

Both yarns have CN code **5402 20 00** with the additional code **TARIC A999** for which anti-dumping duty (ADD) of 9, 8% is prescribed (Regulation 1105/2010). The application is for a period of **2 years**.

Processed product (CN code **5401 10 90**) are:

- PERMA CORE 29/2 – a core spun sewing thread manufactured with continuous filament polyester core and polyester staple wrap designed for most sewing applications;
- FILAN – a thread from continuous filament polyester applied for a wide range of sewing.

Company A&E Europe, d.o.o., Meljska c. 74, 2000 Maribor, Slovenija (hereafter: **company** or **A&E Europe**) imports above mentioned raw materials from China. This two kinds of yarns are sewing thread yarns used solely for manufacturing of sewing thread.

For the Perma Core 29/2 product company imports a 100% polyester spun 2-ply twisted yarn of 29/2 thickness. For the Filan products it imports a 100% high tenacity filament polyester yarn which is twisted with two or three filament yarns.

2. Background Information:

There are more than 135 workers (25 people are employed in the subsidiary Texta d.o.o., Maribor) employed in the company. In order to maintain a premium quality of products the company continuously invests in improvements of finishing processes and new technologies. The company's plan and strategy is to uphold the production of final products in the EU.

Table 1 presents the amount of paid ADD in the past four financial years and theoretical profit or loss before taxes if the ADD would not have been paid. Company didn't take into account the negative impact which arises from the fact that due to the ADD their products are more expensive and thus less competitive. This leads to a smaller volume of sales and subsequently into the lower volume produced. Most of manufacture costs are namely fixed which means that decrease in quantities produced results in a decrease in company's profitability.

Financial years 2012 and 2013 were affected by the recession which had an impact on the demand for final products and thus to the business operation of the company. Company began the financial year 2012 very successfully, but then due to the economic crisis suffered the decrease in sales, first to the furniture and clothing industry and later also to the automotive industry. The customers give more and more importance to the price of the products. Due to additional costs related to the ADD A&E Europe, as a company that manufactures thread in the European Union, it copes increasingly difficult with the competition which offers finished products manufactured in China and India.

3. Reasons to lodge a PCC request

Company A&E Europe offers to its EU customers products based on high quality, value and services. A special emphasis is put on the production and sale of industrial filament thread for the automotive industry.

A&E Europe is focused on the most sophisticated phases of thread manufacturing – the process of finishing. This process includes technologically most complex operations. The imported raw material is treated with the processes of dyeing, stretching, winding and cutting to different lengths in the dye house and precision winding plant located in Maribor. Final products are distributed within the EU as multi-purpose industrial thread. Due to dyeing, winding and other finishing technological processes

that company performs in Slovenia, it is able to offer EU customers products which are made in accordance with their individual, specific requirements and satisfy their very demanding needs when it comes to sewing.

4. Consequences of potential rejection of the PCC request

In the event that the request shall be rejected the company shall have to change its strategy if it wants to stay competitive on the European market. Namely 40% of the production represents the production of Filan and Perma Core 29/2, The company annually manufactures 350 ton of Filan and 141 ton of Perma Core 29/2 from the total annual production volume of 1228 ton of thread. If the request should be rejected then the company shall have to import standard products in a form of final product ready for immediate sale. Since it shall no longer aspire to reach the optimum production level in the amount of 30 tons weekly it shall also begin to import other standard products not just products Filan and Perma Core 29/2. Only the part of the production which is related to the production of specific products, which are especially manufactured for an individual customer, shall remain because the supply period is so short that it must be manufactured in Europe. Hereby, the company shall reduce labor costs and also costs of energy and other production related costs. Due to conversion of the company into a mainly trading company, the number of employees in production shall be significantly reduced.

In total we are talking about termination of approx. 71 workplaces.

In the worst case scenario there is even an option to move the entire company to a territory outside the EU with lower labor costs. This means the loss of all job positions in Slovenia.

The approval of the request for issuing authorisation for processing under customs control would benefit the company to improve competitiveness of products and maintain the production and job positions in Slovenia and in the EU.

5. The calculation of price of goods (with or without the authorisation for PCC).

Table 3 demonstrates the cost price of the product and raw material (yarn) for the most selling products. The cost price is defined according to the method of production costs which means that it includes direct costs of material, direct labor costs, other direct production costs, indirect production costs and indirect selling costs.

Please note that the cost of yarn also includes the freight and related costs, which is why the antidumping duty of 9.8% increases the cost of yarn by approximately 9.3%. In the production of sewing thread the costs of yarn are increased by the cost of dyes, chemicals, labor, water, packing material, energy, depreciation due to use of equipment and other production costs. When the product is finished the antidumping duty still represents 4.9% to 6.8% of the total cost.

MARKET ANALYSIS (EU processors or suppliers of raw material in EU)

The company constantly monitors the offer of raw material on the market and with regard to the offer at a given moment it selects the most suitable suppliers. For the purpose of proving justification

for the issue of the authorisation for PCC the company performed a small market survey in July 2013 where it focused on searching potential suppliers of raw material for their threads on the territory of European Union. In doing so, company first focused on known suppliers from their internal database. Already this internal survey has confirmed that there are remarkably few potential suppliers of raw material for their Filan and Perma Core 29/2 threads. In fact, according to the information, obtained from internal database, there weren't any. .

After that survey of the situation regarding suppliers of twisted yarn was significantly expanded. Company conducted this expanded survey with the assistance of the Chamber of Commerce and Industry of Slovenia who contributed the list of the companies in the EU which engage in the production or sales of twisted yarns. Company sent the demands to all the companies mentioned on the list (Annex 1).

In the market research company asked and tried to obtain information about the manufacturers of twisted two-ply and three-ply filament polyester and core yarn, which is the raw material for Filan final products and twisted spun core polyester yarn, which is the raw material for Perma Core 29/2 final products. In the first group it enquired about sixteen different yarns (for production of FILAN) whose technical specifications are in Annex 2 (see Table 1). And in the second group the company enquired about one yarn of Ne 29/2- thickness (for production of Perma Core 29/2) whose technical specification are in Table 2 of Annex 2.

According to the findings of the market analysis, company established that there are many suppliers of twisted polyester yarn in the EU, however there is only one offering in EU produced high tenacity polyester yarn for thread manufacture. The polyester yarn for thread must be of high tenacity and of low shrinkage. The Company sent technical specifications of requested yarns (specified in Table 1 and Table 2) to the suppliers. It is evident from the tables that the yarn must be of high quality. Most yarns produced in EU do not possess these physical properties, since they are mostly designed for manufacture of flat textiles or other technical purposes (strings, straps,).

In a more detailed review of all the suppliers company established that only one truly matches their demand, because it has an extruding and spinning plant for producing high tenacity polyester on the EU territory. Other received offers failed to correspond to company's specifications or were made for raw material whose origin is in Asia.

Results of the analysis:

- Company tried to contact 125 suppliers
- 62 contacts were without a response
- 13 potential suppliers have no attainable e-mail address or fail to respond to fax
- 45 contacts communicated that they do not have the required yarn in their supply
- 1 contact has appropriate yarn to offer, however it is not the manufacturer of single thread yarn, but it supplies the single yarn from Asia.
- 1 contact has appropriate yarn to offer.

In Annex 1 are presented the results of the research:

With green colour is marked the supplier who can supply the yarn in accordance with company specifications.

According to responses company received from the suppliers who engage in production or sales of twisted thread the suppliers can be divided into following groups:

- those, who have corresponding yarn in their program, however their offers are not economically justified
- those, who do not have corresponding yarn at all or
- the goods are not manufactured in the EU.

This means that company failed to find a direct supplier of twisted filament or core yarn who would have an extruding and spinning plant in EU. The offer of the one company with the extruding plant (PERFORMANCE FIBERS) is from the economic perspective highly unfavorable because this supplier needs to include a contractor to twist their single yarn in order to offer twisted yarn. This of course significantly increases the price of basic raw material, the twisted filament yarn for product Filans.

The company was unable to find a supplier with a production in the EU of twisted core yarn for product Perma Core 29/2.

Manufacturer in the EU

The company PERFORMANCE FIBERS, seated in the Netherlands, with production plant in Germany, is a manufacturer of the single filament polyester yarn and does not have the option of direct supply of twisted three-ply threads. Its primary activity is extruding single-ply yarns of various thicknesses, however they do not have their own twisting plant, their own twisting production of single-ply yarns. The prices they offered for single yarn are indicated in Table 4.

The company Performance Fibers is a manufacturer of filament polyesters designed for twisting filament threads. Since they do not have the option to supply twisted three-ply threads, they found a sub-contract for twisting their single filaments. Thus they sent an offer for products which were the subject of company's demand. Prices obtained from their subcontractor who could twist their raw material for company's needs are indicated in Table 5. The prices for twisted filaments are collected in the column "Total". In comparison with the price of company's supplier from China, they are significantly higher and thus for company needs economically unjustifiable. Company draw the attention to the fact that the presented prices of the supplier from China include costs of

transportation to factory in Maribor Slovenia, whereas the prices of the supplier Performance Fibers do not include the costs of transportation.

Other manufacturers in EU

It arises from Annex 1 that 45 suppliers of yarn responded that they do not have corresponding yarn in accordance with their technical specification at their disposal.

Conclusion:

The survey show that there are no suppliers of spun polyester thread – raw material for the Perma Core 29/2 product in the EU, and for FILAN products (filament polyester thread) there is only one company Performance Fiber, who can supply yarn (single), but whose offer is not economically justifiable for the company.
